NOTICE OF PRIVACY PRACTICES

THIS NOTICE DESCRIBES HOW MEDICAL INFORMATION ABOUT YOU MAY BE USED AND DISCLOSED AND HOW YOU CAN GET ACCESS TO THIS INFORMATION. PLEASE REVIEW IT CAREFULLY.

Urology San Antonio uses health information about you for treatment, to obtain payment for treatment, for administrative purposes, and to evaluate the quality of care that you receive. Your health information is contained in a medical record that is the physical property of Urology San Antonio.

How Urology San Antonio May Use or Disclose Your Health Information

For Treatment: Urology San Antonio may use your health information to provide you with medical treatment or services. For example, information obtained by a health care provider, such as physician, nurse, or other person providing health services to you, will record information in your record that is related to your treatment. This information is necessary for health care providers to determine what treatment you should receive. Health care providers will also record actions taken by them in the course of your treatment and note how you respond to the actions. Urology San Antonio may use your health information when referring you to other health care professionals and facilities.

For Payment: Urology San Antonio may use and disclose your health information to others for the purpose of receiving payment for treatment and services that you receive. For example, a bill may be sent to you or a third-party payor, such as an insurance company or health plan. The information on the bill may contain information that identifies you, your diagnosis and treatment or supplies used in the course of treatment. Urology San Antonio may use your information to contact you about account balances.

For Health Care Operations: Urology San Antonio may use and disclose health information about you for operational purposes. For example, your health information may be disclosed to members of the medical staff, risk or quality improvement personnel and others to:

- Evaluate the performance of our staff
- Assess the quality of care and outcomes in your cases and similar cases;
- Learn how to improve our facilities and services; and
- Determine how to continually improve the quality and effectiveness of the health care we provide.

Required by Law: Urology San Antonio may use and disclose information about you as required by law. For example, Urology San Antonio may disclose information for the following purposes:

- For judicial and administrative proceedings pursuant to legal authority;
- To report information related to victims of abuse, neglect or domestic violence; and
- To assist law enforcement officials in their law enforcement duties

Appointment Reminders and Treatment Calls: Urology San Antonio may contact you to provide appointment reminders or information about treatment plans, medication or test results, other health-related benefits and services that may be of interest to you. When contacts are made via telephone, messages will be left on answering machines with physician name, person calling and telephone number/extension.

Notification: Urology San Antonio may use or disclose information to notify or assist in notifying a family member, personal representative, or another person responsible for your care, your location, and general condition.

Communication with Family: Urology San Antonio's health professionals, exercising their best judgment, may disclose to a family member, other relative, close personal friend or any other person you identify, health information relevant to that person's involvement in your care or payment related to your care.

Business Associates: In some cases, Urology San Antonio contracts with business associates to provide services on its behalf. An example includes arrangements with business associates Urology San Antonio to provide collection services. Urology San Antonio may disclose your health information to such a business associate so that they can perform their respective job functions. To protect your health information, however, Urology San Antonio requires the business associate to safeguard your information.

Public Health: Your health information may be used or disclosed for public health activities such as assisting public health authorities or other legal authorities to prevent or control disease, injury, or disability or for other health oversight activities.

Decedents: Health information may be disclosed to funeral directors or coroners to enable them to carry out their lawful duties.

Organ/Tissue Donation: Your health information may be used or disclosed for organ or tissue donation purposes.

Research: Urology San Antonio may use your health information for drug or research studies when an institutional review board or privacy board that has reviewed the research proposal and established protocols to ensure the privacy of your health information has approved the research. Urology San Antonio may use information to identify qualified candidates for research. Urology San Antonio may use information to make contact with you to determine your interest in the research study/clinical trials.

Physician Board Certification: Urology San Antonio may use your health information to submit to the Professional Certification Board for purposes required for physicians' qualification to complete their specialty board examination.

Health and Safety: Your health information may be disclosed to avert a serious threat to the health or safety of you or any other person pursuant to applicable law.

Food and Drug Administration (FDA): Urology San Antonio may disclose to the FDA health information relative to adverse events with respect to food, supplements, product and product defects or post marketing surveillance information to enable product recalls, repairs, or replacement.

Government Functions: Specialized government functions such as protection of public officials or reporting to various branches of the armed services that may require use or disclosure of your health information.

Workers Compensation: Your health information may be used or disclosed in order to comply with laws and regulations related to workers compensation.

Other Uses: Other uses and disclosures will be made only with your written authorization, and you may revoke the authorization except to the extent Urology San Antonio has taken action in reliance on such.

Urología San Antonio utiliza su información de salud para el tratamiento, para obtener el pago por el tratamiento, para fines administrativos y para evaluar la calidad de la atención que recibe. Su información de salud se encuentra en un expediente médico que es propiedad de Urología San Antonio.

Cómo Urología San Antonio puede usar o divulgar su información de salud

Para el tratamiento: Urología San Antonio puede usar su información de salud para brindarle tratamiento o servicios médicos. Por ejemplo, la información obtenida por un proveedor de atención médica, como un médico, enfermero u otra persona que le brinde servicios de salud, se registrará en su expediente y estará relacionada con su tratamiento. Esta información es necesaria para que los proveedores de atención médica determinen qué tratamiento debe recibir. Los proveedores de atención médica también registrarán las acciones que realicen durante su tratamiento y anotarán cómo responde usted a dichas acciones. Urología San Antonio puede usar su información de salud al derivarlo a otros profesionales e instalaciones de atención médica.

Para el pago: Urología San Antonio puede usar y divulgar su información de salud a terceros con el fin de recibir el pago por el tratamiento y los servicios que recibe. Por ejemplo, se le puede enviar una factura a usted o a un tercero pagador, como una compañía de seguros o un plan de salud. La información de la factura puede contener información que lo identifique, su diagnóstico y tratamiento o los suministros utilizados durante el tratamiento. Urología San Antonio puede usar su información para comunicarse con usted sobre los saldos de su cuenta.

Para operaciones de atención médica: Urología San Antonio puede usar y divulgar información de salud sobre usted para fines operativos. Por ejemplo, su información de salud puede divulgarse a miembros del personal médico, personal de gestión de riesgos o mejora de la calidad y otros para:

- Evaluar el desempeño de nuestro personal;
- Evaluar la calidad de la atención y los resultados en su caso y en casos similares;
- Aprender cómo mejorar nuestras instalaciones y servicios; y
- Determinar cómo mejorar continuamente la calidad y la eficacia de la atención médica que brindamos

Requerido por ley: Urología San Antonio puede usar y divulgar información sobre usted según lo exija la ley. Por ejemplo, Urología San Antonio puede divulgar información para los siguientes fines:

- Para procedimientos judiciales y administrativos de conformidad con la autoridad legal; • Informar sobre información relacionada con víctimas de abuso, negligencia o violencia doméstica; y
- Ayudar a los agentes del orden en el cumplimiento de sus funciones.

Recordatorios de citas y llamadas sobre tratamientos: Urology San Antonio puede comunicarse con usted para recordarle sus citas o brindarle información sobre planes de tratamiento, medicamentos o resultados de pruebas, así como otros beneficios y servicios relacionados con la salud que puedan ser de su interés. Llamadas telefónicas, se dejarán mensajes en el contestador automático con el nombre del médico, la persona que llama y el número de teléfono/extensión.

Notificación: Urology San Antonio puede usar o divulgar información para notificar o ayudar a notificar a un familiar, representante personal u otra persona responsable de su cuidado, sobre su ubicación y estado general.

Comunicación con la familia: Los profesionales de la salud de Urology San Antonio, a su criterio, pueden divulgar a un familiar, otro pariente, amigo cercano o cualquier otra persona que usted identifique, información de salud relevante para la participación de esa persona en su atención o en el pago relacionado con su atención.

Socios comerciales: En algunos casos, Urology San Antonio contrata a socios comerciales para que presten servicios en su nombre. Un ejemplo incluye acuerdos con socios comerciales de Urology San Antonio para proporcionar servicios de cobranza. Urology San Antonio puede divulgar su información de salud a dichos socios comerciales para que puedan realizar sus respectivas funciones. Sin embargo, para proteger su información de salud, Urology San Antonio exige que el socio comercial salvaguarde su información.

Salud pública: Su información de salud puede usarse o divulgarse para actividades de salud pública, como ayudar a las autoridades de salud pública u otras autoridades legales a prevenir o controlar enfermedades, lesiones o discapacidades, o para otras actividades de supervisión de la salud.

Personas fallecidas: La información de salud puede divulgarse a directores de funerarias o forenses para que puedan cumplir con sus deberes legales.

Donación de órganos/tejidos: Su información de salud puede usarse o divulgarse para fines de donación de órganos o tejidos.

Investigación: Urology San Antonio puede usar su información de salud para estudios de medicamentos o investigaciones cuando una junta de revisión institucional o una junta de privacidad que haya revisado la propuesta de investigación y establecido protocolos para garantizar la privacidad de su información de salud haya aprobado la investigación. Your Health Information Rights

- Maintain the privacy of protected health information;
- Provide you with this notice of its legal duties and privacy practices with respect to your health information;
- Abide by the terms of this notice;
- Notify you if we are unable to agree to a requested restriction on how your information is used or disclosed;
- Accommodate reasonable requests you may make to communicate health information by alternative means or at alternative locations; and

Urology San Antonio reserves the right to change its information practices and to make the new provisions effective for all protected health information it maintains.
